IACTS BYLAWS

Article I: Name

1.1 The name of the organization shall be the International Association for China Tourism Studies (IACTS), hereafter the Association, which shall be its short name. IACTS is the acronym of the Association and shall be used among members.

Article II: Vision and Mission

- 2.1 The Association envisages itself as an international academic association that acknowledges the growing importance of China tourism research and the increasing knowledge contribution of China tourism scholars to the tourism scholarship worldwide.
- 2.2 The Association endeavours to:
- promote ethical, rigorous, and quality research practices in China tourism research:
- advance tourism knowledge with theoretical developments in the Chinese contexts:
- encourage international collaborations and scholarly exchange activities among its members to publish quality research in international journals;
- bridge the communication between tourism research community in China and international tourism research community;
- provide cutting-edge methodological training, career guidance and counselling to next-generation China tourism researchers; and,
- provide knowledge-based consulting services to governments, industry and international organisations.

Article III: Membership

3. 1 Founding Membership

The Association is co-founded by a group of academics devoted to China tourism research in Mainland China, Hong Kong, Australia, the United Kingdom (UK), and the United States (US). These founding members are also acknowledged as Co-Founders of the Association and are honoured to be the lifelong members of the Association, unless a founding member would like to forsake the membership herself or himself.

3.2 General Membership

3.2.1 All members of the Association are required to concord on the vision and mission of the Association and should be active researchers in China tourism.

- 3.2.2 General membership of the Association can only be gained though nomination of a current member and upon the approval of the Association's Membership Committee.
- 3.2.3 Members are expected to maintain scholarly activities in relation to China tourism research. A member should have at least two (2) research papers with regard to China tourism published in high impact English or Chinese journals in the past three (3) years. In consideration of different stages of a research career, members over 65 years old can apply for Senior Membership to the Membership Committee, and once approved, can be exempted from the above publication requirement. The Association's Membership Committee will review each membership and advise those who fail to meet the above publication requirement to relinauish membership or decide to terminate membership.

Article IV: Governance

- 4.1 The Association shall be incorporated as a non-profit academic organisation in a country (region) selected by the founding members.
- 4.2 The Association is collectively governed by a Board of Directors. All founding members are *de facto* directors of the first Board. The Board of Directors shall be elected every two years through voting of current members.
- 4.3 The officers of the Association are elected from the Directors of the Board every two years through voting of current members. The officers shall be President, 1st Vice President, 2nd Vice President, and Treasurer.
- 4.4 The office of the President shall normally be limited to no more than two (2) consecutive terms.
- 4.5 A secretariat shall be set up, overseen by the Board of Directors, to manage daily operational matters of the Association. A Secretary General shall be appointed for a term of four (4) years to head the Secretariat.
- 4.6 The Association shall not operate at a deficit.

IACTS BYLAWS -Continued

Article V: Operation Principles

- 5.1 The Association's activities shall be closely aligned with its vision and mission. These activities include, but are not limited to, holding academic conferences, editing research books, organising research training workshops and seminars, visiting scholarships, joint publications among members, and so on.
- 5.2 The Association shall hold a Membership Meeting every two (2) years at such time and place as the Board of Directors shall designate.
 5.3 The Association may undertake consulting or research grant projects entrusted by government or industry bodies. Under such circumstances, project surplus after paying up the necessary dues, will remain in the Association to support its operation.
- 5.4 The Association may establish such financial reserves as considered appropriate by the Board of Directors, subject to the regulations and laws of the country in which the Association is incorporated.
- 5.5 Members are encouraged to offer voluntary personal services, provide personal donations, and introduce donations from the industry to the Association.

Article VI: Working Languages and Communications

- 6.1 The Association's working languages are English and Chinese.
- 6.2 The Association shall provide Internet—based forums/platforms to encourage academic discussions, debates, exchange of ideas, and knowledge sharing among its members.
- 6.3 The Association operates regular newsletters ("China Tourism Research Updates") as a communication tool to promote relevant news and events among its members and the international tourism research community.

Article VII: Changes to the Bylaws

7.1 Changes in the Bylaws shall be made by twothirds (2/3) affirmative vote of the current members voting either in person or by email, provided that the proposed changes have been communicated to all members two (2) months in advance of the proposed date for voting.

Article VIII: Dues

8.1 All members shall pay an annual membership fee as set by the Board of Directors and ratified by the membership.

Sam Huang, together with Associate Professor Ganghua Chen from Sun Yat-sen University and Associate Professor Maoying Wu from Zhejiang University, initiated the Australia-China Tourism Research Network (ACTReNet). ACTReNet is hosted in the School of Business and Law at Edith Cowan University and has its members from universities across Australia and China. It is a virtual international research collaboration platform which brings together researchers in tourism, hospitality, events, leisure and recreation management across Australia and China to collaborate and produce high quality and impactful research outcomes.

China has emerged as an important international tourist destination and source market. Research on China tourism has grown substantially in recent decades, evidenced by the impressive numbers of research publications in relation to China tourism in major tourism journals within and outside China. To date, China tourism has proved to be a significant research field contributing to the growing body of tourism knowledge. The establishment of the International Association for China Tourism Studies (IACTS) (http://chinatourismstudies.org/english) hallmarks the importance of China tourism in the tourism academia.

China tourism research has entered into a new era wherein critical reflections on its past development and prospecting its future directions are needed. This special issue, on the theme of "China Tourism Research: Reflections and Prospects", provides a timely outlet for IACTS Fellows and researchers studying China tourism issues to disseminate their critical thoughts and research findings on China tourism.

Journal of China Tourism Research (JCTR) publishes the latest research on tourism that relates to China and its citizens and encourages interdisciplinary scholarship and commentaries. It provides a rich forum for exchange of fresh information and ideas among academics and practitioners; fosters and enhances cutting-edge research activities that advance tourism knowledge; and discusses the relevance of tourism to the Chinese society. JCTR has recently been adopted by IACTS as its affiliated journal.

Accommodation & Transportation

We understand that the accommodation and transportation cost (international/domestic airfare and transport to the conference venue) relating to your trip **will** be covered by your home institution.

However, we are pleased to make room reservation for you in the conference hotel, if you need it. The conference hotel is yet to be confirmed. We will provide more detailed hotel information in due course.

There is **no** airport in Jiangmen City. However, it is convenient to get to Jiangmen from any airport in Hong Kong, Macau, Guangzhou, Shenzhen, and Zhuhai. It takes 1.5 hours to drive from Jiangmen to Zhuhai Airport, and 2 hours to drive to Guangzhou Airport or Shenzhen Airport. The distance from Jiangmen to Hong Kong by water is 95 nautical mile and is 53 nautical mile to Macau. High-speed luxury (ferry) liners travel between Jiangmen and Hong Kong, Macau every day.

About Jiangmen City

Jiangmen -- Meeting point of Eastern and Western Cultures and the Capital of Overseas Chinese.

Jiangmen is known as the Capital of Overseas Chinese. Overseas Jiangmen natives live in 107 countries and regions across five continents, mainly in the United States, Canada, Southeast Asia, Hong Kong, and Macau. In total, there are 4 million overseas Chinese and Hong Kong, Macau, Taiwan compatriots.

The blending of eastern and western cultures has shaped a unique culture in Jiangmen as a hometown of overseas Chinese and turned Jiangmen into the meeting point of eastern and western cultures.

Kaiping Diaolou in Jiangmen is the representative form of cultural heritage for the hometown of overseas Chinese. In 2007, Kaiping Diaolou and villages were enlisted in the World Cultural Heritage Directory by UNESCO. This is the only World Cultural Heritage Site in Guangdong province. Kaiping Diaolou combines the eastern and western architectural cultures, and thus is praised by experts as "the architectural art gallery which astounds the world" and "the most beautiful village in the world".

Third East-West Dialogue Tourism and the Chinese Dream: Managing tourism for sustainable growth

Gold Coast, Australia 23-25 November 2017

The 'Chinese Dream' is an aspirational concept initiated by the President of China, Xi Jinping, based on the traditional Chinese philosophy of dedicating oneself to the wellbeing of family, country and the world. The successful First East West Dialogue (Gold Coast, 2014) and the Second East West Dialogue (Shanghai, 2016) discussed tourism as a major contributor to the Chinese Dream.

The Third East-West Dialogue Chinese Dream will be held on the Gold Coast, Australia, between 23-25 November 2017 explores the 'China Dream is closely linked to an ecologically harmonious society. This notion is termed 'Eco-civilisation', a form of development, ethic, or blueprint for an environmentally compatible society, now firmly embedded in China's policy context.

The Third East-West Dialogue will provide a platform to discuss how tourism can contribute to the theory and implementation of a new Eco-civilisation, within China and in those countries that are visited by Chinese tourists.

The Third East-West Dialogue forms part of two major initiatives in 2017, namely the United Nations International Year of Sustainable Tourism for Development and the China-Australia Year of Tourism. As a world-leading institution in tourism education and research, Griffith University, through its **Tourism Confucius Institute** (TCI) and **Griffith Institute for Tourism** (GIFT), is pleased to invite you to attend to this timely event.
